# The role of NRENs in data management

#### Why are NRENs relevant for data management?

- Researchers are based in institutions so core provision to store, collaborate, publish, share data comes from uni
- NRENs provide the main elnfrastructure for services to work
  - Network connection
  - Trust and Identity services e.g. eduroam
  - Increasingly offer 'above-net' data services e.g. Researchdrive, DMP tools, ELN...
  - Can help to broker service contracts e.g. to CRIS systems via HEAnet
- Universities are members of NRENs so they can help provide national advocacy and coordination




#### What are unis doing to help?

- Offering various services throughout the lifecycle
- Consulting with researchers on DMPs to plan well from start
- Running training courses to increase data skills
- Providing data stewards / software engineers as part of team
- Coordinating strategy at institutional level RDM boards



#### Institution often have many data services in place

#### **Challenges faced when delivering RDM services**

- Different service units are often responsible for each system
- Services are not always acquired systematically with a view of data exchange / connections between systems
- There's a lack of interoperability across research systems lots of reentering of data, poor join-up
- Need to coordinate across actors, within universities and across unis
  - role for NRENs?



#### **Role of NREN in national Open Science coordination**




- 20 NRENs plus GÉANT are Members of the EOSC Association

- 12 of these NRENs have been appointed as Mandated Organisations to represent national interests



One contract, but each institution can have local front-end and admin

ULAKBIM runs Aperta as a multidisciplinary open data repository for all researchers in Turkey

Assigns DOI and uses schema.org metadata



Cloud-based shared-storage for large quantities of data
Personal cloud storage service
Uploading data to SURF via hard disks
Send & receive large files via a web-based tool, secured with encryption
